Re: Notice to the Secretary of the Nomination of Persons for Election as Directors at the 2023 Annual Meeting of Stockholders of Vincoventures, Inc.

Dear Mr. Noble:

I, Austin L Gilmore, pursuant to Section 2.5 of Article II of the second amended and restated bylaws of Edison Nation, Inc., a Nevada corporation (predecessor via merger to Vincoventures, Inc., a Nevada corporation) (the "Company") (the "Bylaws"), hereby notify you that I intend to nominate three persons as directors for election to the Board of Directors of the Company (the "Board") at the 2023 Annual Meeting of Stockholders of the Company, or any other meeting of stockholders held in lieu thereof, and any adjournments, postponements, reschedulings, or continuations thereof (the "Annual Meeting").

This letter, including the exhibits and schedules hereto, as well as the documents incorporated by reference herein, are collectively referred to as the "Notice." The persons I intend to nominate for election to the Board at the Annual Meeting are Shadwick J. Vick, Lorne Ross, and Christopher L. Muntz (each a "Nominee" and collectively, the "Nominees").

No annual meeting of stockholders was held by the Company during 2022. Pursuant to Section 2.5 of Article II of the Bylaws, if the date of the annual meeting is more than 30 calendar days before or more than 70 calendar days after the first anniversary of the preceding year's annual meeting, then notice of a stockholder's nomination for director must be delivered not earlier than the close of business on the 120th calendar day prior to such annual meeting and not later than the close of business on the later of the 90th calendar day prior to such annual meeting or the tenth calendar day following the day on which public announcement of the date of the annual meeting is first made by the Company. The Company announced the date of its 2023 Annual Meeting in its Preliminary Proxy Statement (Form PRE 14A) filed on March 9, 2023. This notice is timely because it is provided by the tenth calendar day following March 9, 2023.

I believe that the Board is currently composed of five members. To the extent that the Company might purport to increase the size of the Board and/or the number of Directors, I reserve the right to nominate additional nominees for election to the Board at the Annual Meeting. Any additional nominations made pursuant to the preceding sentence would be without prejudice to the issue of whether such attempt by the Company to increase the size of the Board and/or the number of Directors was valid under the circumstances.

Pursuant to Section 2.5 of Article II of the Bylaws, the undersigned hereby sets forth the following:

- (a) The stockholder giving this Notice and intending to make the nominations set forth herein is Austin L. Gilmore.
- (b) My name and address, is Austin L. Gilmore of Lewisville, Texas. Please direct correspondence to Austin L. Gilmore c/o Patrick B. Horne, Shumaker, Loop & Kendrick, LLP | 101 South Tryon Street, Suite 2200 | Charlotte, North Carolina 28280.
- (c) I am a beneficial holder of record of Common Stock entitled to vote at the Annual Meeting and intend to appear in person or by proxy (virtually, as no in-person meeting will be held according to the preliminary proxy statement) at the Annual Meeting to nominate the Nominees specified herein.
- (d) Information regarding each Nominee required to be disclosed pursuant to Section 2.5 of Article II of the Bylaws is set forth in Exhibits A through C hereto.
- (e) Pursuant to Section 2.5(a) of Article II of the Bylaws, the consent of each of the Nominees to (a) being nominated for election to the Board; (b) being named in a proxy statement and other proxy related materials filed with the United States Securities and Exchange Commission as a nominee for election to the Board; and (c) serving as a director on the Board if elected, are attached hereto as Schedule A.
- (f) Pursuant to Section 2.5(e) of Article II of the Bylaws, a certification that the stockholder giving the notice and the beneficial owner(s), if any, on whose behalf the nomination is made or the business is proposed, has or have complied with all applicable federal, state and other legal requirements in connection with such stockholder's and/or each such beneficial owner's acquisition of shares of capital stock or other securities of the corporation and/or such stockholder's and/or each such beneficial owner's acts or omissions as a stockholder of the corporation, including, without limitation, in connection with such nomination or proposal is set forth in Schedule B.
- (g) I am the beneficial owner of 64,036.83 shares of the Company's common stock, par value \$0.001 per share ("Common Stock"). For certain information regarding transactions in securities of the Company, see Schedule C hereto. I will notify the Company in writing within five (5) business days after the record date for the Annual Meeting of the class and number of shares of stock of the Company owned by me of record or beneficially as of the record date for the Annual Meeting.

In addition to the foregoing, certain information regarding the qualifications of each Nominee responsive to the criteria and attributes said to be considerations for the Company's Nominating and Corporate Governance Committee as described in the Company's 2023 preliminary proxy statement is set forth in Exhibits A through C hereto (without conceding that any such information is required to be disclosed in this Notice). I expect that, if elected, each Nominee is prepared to commit sufficient time to attend to his duties and responsibilities as a member of the Board.

Except to the extent set forth in this Notice, as of the date hereof: (i) no Nominee has been involved in certain legal proceedings described in 17 CFR § 229.401(f) during the past ten years that are material to an evaluation of the ability or integrity of the Nominee as a potential director; (ii) there is no transaction, or series of similar transactions, or any currently proposed transaction, or series of similar transactions, to which the Company or any of its subsidiaries was or is to be a party, in which any Nominee or any associate of any Nominee, or any member of the immediate family of any Nominee, had, or will have, a direct or indirect material interest; (iii) no Nominee at any time has been indebted to the Company or any of its subsidiaries; (iv) no Nominee or associate of any Nominee has any arrangement or understanding with any person with respect to: (a) any future employment with the Company or its affiliates (except in the capacity as a director); or (b) with respect to any future transactions to which the Company or any of its affiliates will or may be a party; and (v) other than fees paid to outside directors that are consistent with the Company's past

practice, no Nominee has any substantial interest, direct or indirect, in the matters to be acted on at the Annual Meeting, except his interest in being nominated and elected as a director and his interest as a common stockholder.

I expect that each Nominee will furnish such other information with respect to such Nominee as the Company may reasonably require to determine the eligibility of such Nominee to serve as a director of the Company (without conceding the validity of any such requirement or request for additional information).

I trust that this Notice complies in all respects with the Bylaws and applicable law. If the Company believes this Notice is incomplete or otherwise deficient in any respect, please notify me in writing immediately of such alleged deficiencies. I reserve the right, following receipt of any such notice, to either challenge, or attempt to cure, any alleged deficiencies. I also reserve the right to give further notice of additional business or nominations to be conducted or made at the Annual Meeting or other meetings of the Company's stockholders, to revise the nominations described herein, or not to present any one or more nominations described herein.

If this Notice shall be deemed for any reason by a court of competent jurisdiction to be ineffective with respect to the nomination of any of the Nominees at the Annual Meeting, or if any individual Nominee shall be unable to serve for any reason, then in addition to any other rights or remedies I may have, this Notice shall continue to be effective with respect to the remaining Nominee(s) and as to any replacement Nominee(s) I select. The delivery of this Notice shall not be deemed to limit in any respect any of my rights as a stockholder of the Company, including, without limitation, under the Bylaws.

I trust that the Board will hold the Annual Meeting on its scheduled date of April 18, 2023 and, in any event, will not impose on the Company and its stockholders the expense and other consequences of an attempt to delay the Annual Meeting or the need for action by a court to compel an annual meeting in accordance with Nevada law. The delivery of this Notice shall not be deemed to limit in any respect any of my rights as a stockholder of the Company, including, without limitation, under the Bylaws.
